



## “Sweet Treat” Giveaway Sweepstakes

### OFFICIAL RULES

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.**

1) **Eligibility:** The Sweet Treat giveaway Sweepstakes (the "Sweepstakes") is offered to pre-registrant attendees who, pursuant to these Rules, register for ("Entrants") and then actually attend (and pick up a valid attendee badge) the National Stationery Show, which takes place from February 3-6, 2019 at the Javits Center in New York City, NY (the "Event").
